The fair brought together representatives from partner financial institutions and organizations that help service members implement plans to spend less and save more to meet current and future financial goals. The expanding network of participating Military Saves organizations is demonstrating its commitment to the financial readiness of the military community by offering many savings products. During Military Saves Week, installations around the world hosted events encouraging Service members and their families to take the Saver Pledge and take advantage of the range of tools and resources available to help them meet debt reduction and savings goals. If you are one of the many Active and Reserve Component (AC/RC) service members who have just received this news, may I offer some advice?

Who delivered the news? Name, Rank, and Position...

And the hardest question—Why? Take every brochure and pamphlet they have to offer and make note if they offer no guidance. Request copies of all paper work involved in this action, make clear and concise notes. There is very little chance to appeal this action but without the documentation there is no chance.

Keep in mind this is a long journey and you must do it without anger. Sit in every TAP class they offer, listen and again take notes and if the information is not sufficient tell someone. There are a myriad of programs and organization to help you along the way and remember you are not alone.

Now start thinking of what you're going to do with the rest of your life. Do not limit yourself, think big! When veterans left the service after WWII they thought of college degrees and starting their own businesses.

Some became congressmen, senators and even president, and we could sure use a few veterans in those positions today!

Senator Webb on TRICARE:

The people serving right now are watching how we take care of retirees

During an Armed Services Committee hearing, Senator Jim Webb, Chairman of the Senate Armed Services Personnel Subcommittee, today said that the American people need to understand what the proposed TRICARE changes look like "from the experiences of someone who has spent a career in the military."

"All of this boils down to what a soldier or Marine or sailor or someone in the Air Force can see about what happened to the people who went before them—how they were treated after they left the uniform," said Senator Webb. "I grew up in the Marine Corps tradition and no Marine is ever left behind, and I feel just as strongly about the commitment that we have made to lifetime medical care for the people who have served.

"We know we have a problem with medical care. It is a national problem...It is not simply a DoD problem," said Senator Webb. "I do not believe that we should allow ourselves to characterize the commitment that we have made as a throw-away matter as we try to balance out other issues. How we take care of these people is one of the great litmus tests that people who are serving right now are going to be looking at."

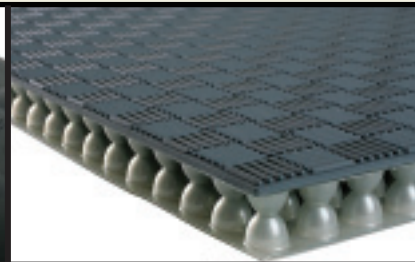

Coastie Corner

Sector Los Angeles/Long Beach Reserve Sector Boarding Team Making a Difference On Their Civilian Days Off

The Coast Guard Reserve Sector Boarding Team (RSBT) of Sector Los Angeles-Long Beach and the Los Angeles Port Police conduct regular boardings of small, recreational vessels in the ports of Los Angeles and Long Beach during their drill weekends. By providing day-to-day support of Coast Guard missions in the port, the RSBT develops competencies and sharpens skills for use in future contingency operations – either locally or wherever the need arises.

The boarding team utilizes both active duty and reserve Coast Guardsmen, including LT Carter Fenstermacher, Chief James Lanigan, BM1 Richard Magana, MK2 Richard Quichocho, and ME3 Justin Olson as well as partnering with members of the Los Angeles Port Police. And, this mix of full and part time professionals is making a difference.

During a routine boarding earlier this year, the inter-agen-

cy team encountered four Mexican nationals who were in the United States illegally. The team terminated their voyage and detained the individuals. The detainees were transported to the Sector Los Angeles-Long Beach boat basin and transferred into the custody of U.S. Customs and Border Protection. A Coast Guard Station Los Angeles-Long Beach boat crew towed the vessel to Cabrillo Marina, where it was released to the family members of the detainees.

This is but one example of how consistent training and the hard work of maintaining certifications pay off when the time comes to execute real world operations. The opportunity to conduct joint operations with local law enforcement partners is extraordinary. Additionally, the opportunity to work in concert with other local Coast Guard units helps to maintain our ongoing and seamless working relationship.

Legislative Updates

Servicemen's Civil Relief Act (SCRA)

Overview

The SCRA provides legal protection for service members and their families who are ordered to active duty. The Act also provides protection for difficulties meeting some financial and legal obligations due to their active duty service.

This is not a comprehensive assessment of all the provisions of the SCRA, but only a review of some of the key provisions. The complete Act can be found in 50 USC 501.

This Act only applies to transactions, loans, leases and contracts entered into prior to entering active duty.

Following are some of the key areas that are covered:

Credit Card and Mortgage Debt

- Interest capped at 6% per year while on active duty status.
- The financial institution must be notified in writing of the activation and provided with a copy of the orders.
- Effective for up to 90 days after release from active duty.
- No pay back of interest charges above the 6% that normally would have been charged.

Mortgage Foreclosure Protection

- Provides protection from foreclosure for those ordered to 180 days or more of active duty.
- Protection is effective for up to 9 months after release from active duty until Dec. 31, 2012. NOTE: NERA and the other members of The Military Coalition are actively supporting legislation to permanently extend this to 1 year after release from active duty.
- Mortgage holders are required to search the DoD supplied data base of all active duty service members to determine eligibility. Letters of notification and copies of orders are not required from the member for this protection.

Civil Court Actions

- Provides for stays of up to 180 days for civil court ac-

tions such as bankruptcy, foreclosures and divorce.

- Does not apply for criminal actions.

Cell Phone Contracts

- Allows termination of cell phone contracts for those deployed outside the U.S. for more than 90 days.
- Must notify the contractor in writing with a copy of orders included.
- Prohibits charges for "termination fees" and/or "reactivation fees".

Rental Eviction Protection

- Protects against eviction from rental housing.
- Must notify the landlord or lease holder in writing with a copy of orders included.
- Protection is for set maximum dollar values of rent for housing that are published in the Federal Register by the Secretary of Defense is adjusted annually for inflation. The current maximum is \$2720.95.

Taxes

- Prevents states from calculating the service member's earned income in determining a spouse's tax rate when they do not maintain their permanent legal residence in that state.

If you have questions or issues related to the SCRA you should contact your unit Judge Advocate General (JAG) officer or designated legal affairs officer. You should also make your spouse and/or responsible family member(s) aware of these protections. •

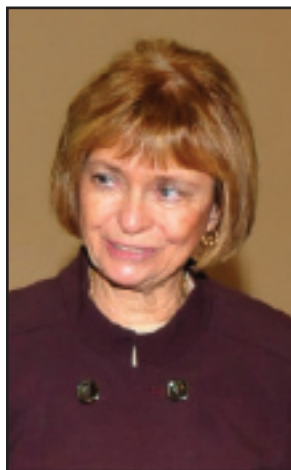

Replacement DD 214/Service Record

If you retired prior to 1/1/1995, go to www.archives.gov/veterans to request a DD214. If you retired after 1/1/1995, send NAVPERS 1070/882 to:

You can also fax your request to 901-874-2664. Go to www.npc.navy.mil. In the search box at the top right hand corner type in NAVPERS 1070/882. This will bring you to another screen. Click on the first form and it will download to your screen a fillable form which you can fill out and print.

Burial at Sea Information

Call 866-787-0081 or go online to www.npc.navy.mil. When you go to the website, search for the Burial Request form and print it out. You will also need:

- (1) a photocopy of the death certificate
- (2) the burial transit permit or the cremation certificate
- (3) a copy of the DD Form 214, discharge certificate, or retirement order.

2013 Defense Budget

Last year Congress passed a law that would limit future TRICARE fee hikes for retirees to no more than the COLA increase in retirement pay. However, military officials (at this writing) now want to tie the increase to the rate of medical inflation, which now runs 7% or higher. Given the fact that the military retirees have only received 3.6% once over the last few years, there is much cause for alarm. They are also looking into charging retirees over age 65 an enrollment fee for Tricare for Life. Of course, the Pentagon claims that these fees will remain below levels in most of the private sectors. Let's see if our retirees whose annual retirement is between \$10,000 to \$20,000 (roughly all the enlisted reservists and most of the E-6 and below) will agree with this view. - ☐ Four \$2,500 scholarships for any Regular or Associate NERA member or any spouse, son, daughter or grandchild of a regular NERA member. Children and grandchildren must be unmarried and under age 23.

ELIGIBILITY

To be eligible for the scholarship the applicant must be either a NERA member, regular or associate. NERA members may also sponsor a qualified applicant: a spouse, son, daughter or grandchild. Sponsored children and grandchildren must be unmarried and under age 23 on 4 June 2012.

In order to qualify for the scholarship the applicant or sponsor must be a member in good standing by the scholarship deadline, 4 June 2012. Members must have their dues paid up to date and new memberships must be paid in full by the scholarship deadline, 4 June 2012. If you have any questions regarding your eligibility please contact NERA at 800 776-9020 or by email at members@nera.org.

Eligible students – must attend undergraduate level studies at a college, university or junior/community college that confers a bachelor's or associate's degree, on a full or part-time status as established by the school accepting the scholarship funds. Academic programs involving a second undergraduate or graduate school degree are not eligible.

SCHOLARSHIP USE REQUIREMENTS

Scholarship applicants may be either graduating high school seniors or students already attending a college, university or junior/community college. Applicants must be enrolled or planning to enroll, full-time or part-time in the fall semester immediately following award of the scholarship. Enrollment may be in any undergraduate program leading to a bachelor's degree or associate's degree at an accredited college or university.

The NERA Scholarship can be awarded in addition to any other partial scholarship, including a ROTC Scholarship. Those applicants already in possession of an appointment to a U.S. service academy or receiving a "full scholarship" to any accredited college or university are not eligible. A "full scholarship" is usually defined as one that provides for payment of tuition, books, lab fees, and university supplied dormitory room and board.

ESSAY REQUIREMENT: One 500 word essay chosen from one of the two topics listed below.

FIRST ESSAY CHOICE: Personal Goals and Objectives

In 500 words state your career goals and objectives for your education. Direct your comments to how you think your college education will benefit you or others in keeping with your career goals and objectives.

SECOND ESSAY CHOICE: "Why Are Reservists Important to America?"

In 500 words, answer above question.

NERA's Gold County Chapter held their sixth annual Children's Christmas Party on December 17, 2011 at the BT Collins Army Reserve Center.

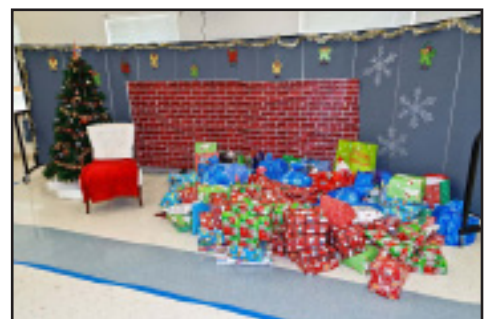
